# **Course Description**

This course provides an approach to Human rights in Latin America, to the consolidation of social movements and to the main challenges that they face at present

Social Movements in Latin America are currently a space for the promotion and defense of Human Rights. At the same time, several social rights leaders have been killed in the region, which makes the situation more complex. Social Movements put into practice the International Human Rights conception and propose a regional thinking that reviews and enriches it.

This course will allow students to understand Latin American conceptions of rights and development, within the International System. It will also delve into the origin and role of Social Movements in the region and their struggle for the defense of Human Rights. Also, it will address a Human Rights agenda for Latin America, dealing with issues of land rights, poverty, labor, environment, ethnicity, gender and quality of life.

Selected bibliography, class discussion and case studies from Latin America and Argentina will be included. The course will incorporate site visits and interviews with leaders.

# **Students Learning Outcomes**

By the end of the course, students will be able to:

- Analyze the process followed by Social Movements in Latin America and their role in the defense of Human Rights and Democracy.
- Identify the application of main concepts and principles from the International Human Rights System in the Latin American context, taking into consideration its historical circumstances
- Assess the role of Social Movements in Argentina and Latin America in relation with public policies in recent decades
- Identify present challenges for Human Rights in Latin America regarding the environment, land rights, labor, citizenship, gender, sexuality and quality of life
- Consider the experience of interacting with other cultures related to activism and academic studies related to Social Movements and Human Rights.
- Analyze Development theories oriented to the full respect of Human Rights and the pursuit of "good living" (buen vivir/sumak kawsay) and justice

### **Course Structure**

### **Class Dynamics**

Classes will comprise students individual and group work, as well as class discussions and presentations by the Instructor. Concepts will be developed through videos, research in the media, PowerPoint presentations and printed documents. Popular songs and newspaper clippings will be used as learning materials as well.

Students will carry out fieldwork, aimed at the production of class discussion materials and the elaboration of a Final paper. Discussion groups will be formed in order to deal with textual materials, both from academic literature and written media, following the professor's instructions.

Individual academic papers will be the result of the analysis of a course topic chosen by each student, prepared both at home and in a class workshop.

Each class will be closed by asking students for questions and suggestions and a 5-minute exposition with conclusions from the instructor.

# WEEK 1 INTRODUCTION: LATIN AMERICA, SOCIAL MOVEMENTS IN DEFENSE OF HUMAN RIGHTS

General view of the three conceptual axes. Course presentation, including goals, activities and evaluation. Class conversation about expectations and personal involvement in the subject of the course.

Video projection. Power point presentation and individual work.

Civil Society, NGOs and Movements. Main aspects of Social Movements today. Theories and concepts. European and American approaches. Specific aspects of Latin American Social Movements.

#### **WEEK 3 INTERNATIONAL HUMAN RIGHTS SYSTEM**





Concepts related with a Human Rights view. Universal Declaration of Human Rights. International Covenants. Courts and Tribunals. Internaerican System. Economic, Social and Cultural Rights. Human Rights in UN Sustainable Development Goals.

Video projection and questions over readings. Class dialogue. Case studies.

# WEEK 4 HUMAN RIGHTS AND DEVELOPMENT PERSPECTIVE FROM LATIN AMERICA

Global South thinking and Latin American perspective. Solidarity, Development and Human Rights. Role of Social Movements and relation with poverty and social issues.

Work with documents. Groups and class debate. Video projection.

### **WEEK 5 HUMAN RIGHTS IN LATIN AMERICA: A HISTORICAL VIEW I**

# WEEK 6. HUMAN RIGHTS IN LATIN AMERICA: A HISTORICAL VIEW II

XXth Century. Populism and economic independence. The influence of the Cold War and the Doctrine of National Security. Armed forces and dictatorships. Human Rights in the 60s and 70s. The cases of Chile, Uruguay, Brazil and Argentina and the "Plan Condor".

Powerpoint presentation, video projection. Case studies.

# WEEK 7. ARGENTINA: RESISTANCE TO DICTATORSHIP AND THE HUMAN RIGHTS MOVEMENT

Overview of Argentina and its history. Main aspects of the 1976-1983 Dictatorship. The "Madres de Plaza de Mayo" and human rights organizations in Argentina. Human





Rights as a state policy. Trial of civilian and economic corporations in cases of human righs violations.

Students presentations based on selected bibliography. Class debate.

### **WEEK 8 POVERTY AND EXCLUSION IN LATIN AMERICA DURING THE 1990S**

Neoliberalism in the region: economic and political aspects. Social impact. The defense of the rights of identity, autonomy and social justice in state projects. Rise and consolidation of "new social movements".

Interview with a Human Rights leader.

# WEEK 11 TOWARDS A HUMAN RIGHTS AGENDA: LAND, HABITAT AND WORK

Land and Labor in Latin America. The MST (Landless Workers Movement) of Brazil. Right to work. Situation of the labor movement in Latin America. Movements of unemployed people and organizations in Argentina: "Piqueteros" and Recovered Factories.

Students will share case analysis through selected readings and movies.

# WEEK 12. CULTURE, BIODIVERSITY AND THE RIGHT TO "GOOD LIVING"

Indigenous movement and current discussions. The situation of Afrodescendants and their culture. Discrimination, interculturality and integration. Defense of the right of peoples identity, autonomy and social justice. Development from a Latin American perspective. The right to "good living" ("buen vivir/sumak kawsay"), experiences in Ecuador and Bolivia.

Students presentations on the subject. Video projection and group discussion.

# WEEK 13. RIGHTS RELATED TO BODY, GENDER AND SEXUALITY

Body, gender and sexuality main concepts. Organization and movements in Latin America. Feminism. Women's movements in Latin America and Argentina. The experience of "Ni una menos". LGTBIQ. Laws and current situation in Argentina.

Students selected presentations on the subject. Video projection and group discussion.
